Modules	Description
Supplier Quality Settings	Configure roles/permissions and notifications across sites; link FOSS instruments to goods received; manage material/service lists and specs for incoming goods.
Supplier Information	Onboard and manage suppliers and sites; keep compliance docs, collect updates via questionnaires, manage contacts and material-to-site links, and track changes and communications in the timeline and log.
Template Management	Create standard questionnaires for specific requirements for your suppliers as well as standardized checklists for goods received.
Goods Receiving	Record every delivery. All documentation in one place for traceability. Apply up to date checklists, attach photos and relevant documentation. Document every measurement Automatic data input from FOSS instruments.
